

When the Lights Go Out: Healthcare Resiliency

In December 2022, an intentional shooting attack damaged two electrical substations in Pinehurst, North Carolina. The extended outage left FirstHealth Moore Regional Hospital, and 37,000 other utility customers, without power for days. 
